6. Bid bond of 1% of bid price in form of bank guarantee or Insurance firm and must remain valid for 120 days from the date of tender opening.
7. A declaration form of list of on-going projects with the County Government of Taita Taveta.
8. A certificate of site visit form

There will be a **mandatory** site survey on **Friday 4th July 2014**. Bidders will meet at Tavevo Offices Voi at 9.00am. For Chumvini Water Project bidders will meet at Ministry of Water offices in Taveta. (Bidders who participated in the previous tender need not visit but must attach signed site visit forms).

Tender Documents in **plain sealed envelopes marked with Tender Number** must be deposited at the **Ministry of Water Tender Box** at the County Head offices in Wundanyi before the specified date and time. Late tenders will be rejected and returned to the tenderers unopened.
